4. Evaluation of the collaboration and its perspectives

The collaboration between our institutes started thanks to Erasmus student exchange program in 2007 and it was originally initiated by senior professors of our Departments. Shortly after we have met at the 1st Adriatic forum conference in Koper, Slovenia in December 2008 and realized our common research interests in cross-border collaboration research. During the next meeting, at Deutsches Geographentag in Vienna in September 2009 we decided to make the next step for strengthening of our collaboration and Aktion program was optimal for it. After the first unsuccessful submitting of the research project in autumn 2009 we submitted it in the next call in spring 2010 and we were successful. Since than the collaboration is much deeper and broader and it has its solid base – the common research grant. Despite its relatively small size (in terms of the budget) there was achieved quiet impressive ammount of common meetings, presentations at the conferences, common aims and methodologies of the student's field works. And of course the tangible results will be three common publications in peerreviewed journals. Without Aktion project we are pretty sure that we would never achieve such a level of collaboration between our institutes. For the future collaboration we plan to go on in the topic of human geography. We would also like to use the opportunity for our students in the framework of excursions to Austria/Czech rep. in the framework of Aktion project.
